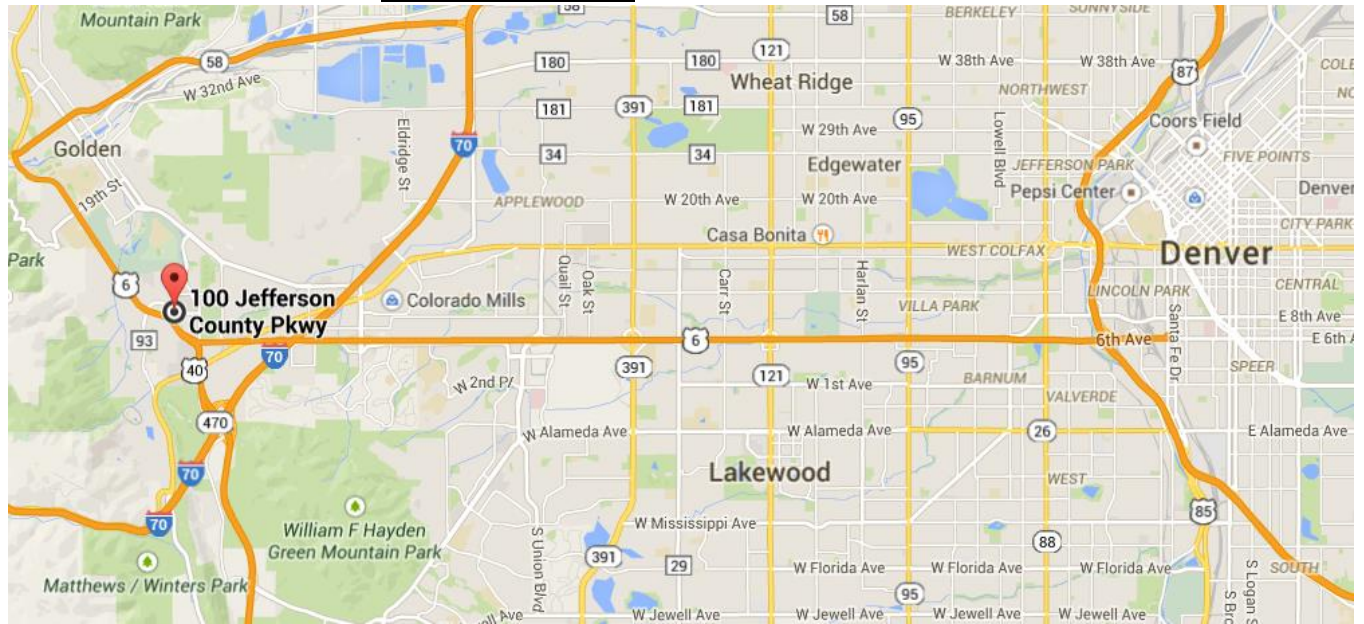

From the East:

I-70 West, Exit Colfax (262)-Right on Colfax, Slight Right Merge onto 6th ave (US-6), Right on Johnson Road, Left on Jefferson County Parkway.

From the South:

I-25 North to I-70 West, Exit Colfax (262)-Right on Colfax, Slight Right Merge onto 6th ave (US-6), Right on Johnson Road, Left on Jefferson County Parkway.

From the West:

I-70 East, Exit Colfax (262)-Right on Colfax, Slight Right Merge onto 6th ave (US-6), Right on Johnson Road, Left on Jefferson County Parkway.

From Denver:

6th Ave West, Right on Johnson Road, Left on Jefferson County Parkway.
